Acquisition of Shares in Dialysis Information Management System Software Development Company in Belgium (Conversion into Subsidiary)

Nipro Corporation ("Nipro") hereby announces that Nipro Europe Group Companies N.V. (Main office: Mechelen, Belgium; Representative: Tsuyoshi Yamazaki, President; "NEGC"), the Group's regional headquarters in Europe, has acquired all outstanding shares in NephroFlow N.V. (Main office: Bruges, Belgium; Representative: Simon Dusauchoit, President; "NephroFlow"), a company that develops software for dialysis information management system in Belgium, and has turned NephroFlow into a subsidiary.

1. Reasons for acquiring shares and change of company name

In Japan, Nipro has been marketing DiaCom[®], an in-house developed dialysis information management system. However, the management has concluded that it is effective to adopt NephroFlow's system that has already established a track record in Europe to promptly meet customers' demands in Europe. In addition, with its aim to fulfil the growing demand for dialysis information management systems, to further grow its market share and to expand the business, Nipro has acquired the shares in NephroFlow. To that end, Nipro will (1) responsively and actively improve and develop NephroFlow's system and (2) develop a further optimized system by incorporating the advantages of DiaCom[®] into NephroFlow's system. Nipro has changed the name of the acquired company to Nipro Digital Technologies Europe N.V. after converting it into a subsidiary.
