

Notice of Trade Name Change of Medical Software Subsidiary

NIPRO CORPORATION is pleased to announce that one of its subsidiaries, Nipro System Software Engineering Co., Ltd. (Head office: Shinjuku Ward, Tokyo; President: Kimihito Minoura) changed its trade name to Nipro Digital Technologies Co., Ltd. on October 1, 2025.

NIPRO Group has been expanding its business in the global market as a comprehensive healthcare company, and it continues to grow steadily; in FY 2024, the Group's overseas sales exceeded 50% of total revenues.

In these circumstances, the Group will strengthen its support for digital transformation (DX) across the entire medical industry by leveraging AI and digital technologies. This will allow us to accurately understand and quickly respond to market needs in each region to improve the quality of life (QOL) of patients and lessen the load of medical professionals, while also advancing new treatment technologies.

In June 2016, the Group established Nipro System Software Engineering Co., Ltd. Since then, the company has been developing and providing software for the Japanese medical field, such as the dialysis information management software DiaCom and the medical device data communications support system HN LINE to boost operational efficiency and improve safety at medical facilities. Also, in December 2019, the Group acquired the dialysis information management system software development company from Belgium, NephroFlow N.V. (currently Nipro Digital Technologies Europe N.V.). We have continued to expand into the EU region, as well as into South America and India. Going forward, we will build a data platform that will become the Group's global business infrastructure to support our extensive business expansion, and continue our efforts to optimize supply chain management that is compatible with the increasingly complex and multilateral procurement and supply networks.

These initiatives for the DX of the medical industry go beyond simply introducing the latest technologies; they must also provide solutions that are closely aligned with the particular features and issues of each region.

This trade name change will unify NIPRO's brand image in the global market, and accelerate these initiatives for the DX of the medical industry on a global level. The Group is aiming to collect and apply various data, while also using these initiatives to actively cultivate and grow new business

fields.

Under this new trade name, NIPRO Group will continue to provide community-based, attentive services while striving to meet the needs of the medical treatment front line while also further expanding the company's business activities around the world.
